

# **TERMS OF USE**

# 1. AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Znośnie Software Wiktor Pabich ("Company," "we," "us," or "our"), concerning your access to and use of the Dev-Jobs.pl website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site").

By posting User Content, you grant us a non-exclusive, worldwide, royalty-free license to use, copy, modify, and display your User Content for the purpose of operating and improving the Site.

#### 6.4 License to Other Users

- Job postings are publicly visible to all Site users
- Resumes and applications are only shared with employers to whom you apply, unless you explicitly make your profile public

# 7. PROHIBITED ACTIVITIES

You agree not to:

#### 7.1 For All Users

- Use the Site for any illegal purpose or in violation of any local, state, national, or international law
- Harass, abuse, or harm another person
- Impersonate or attempt to impersonate the Company or another user
- Attempt to bypass any security measures of the Site

#### 7.2 For Employers

- Post fake or fraudulent job listings
- Post jobs that discriminate based on race, gender, religion, age, disability, or other protected characteristics

 Use the Site to collect personal information for purposes other than considering candidates for employment

### 7.3 For Job Seekers

- Submit applications for jobs for which you are not genuinely interested
- Misrepresent your qualifications or experience
- Submit applications on behalf of others without their consent
